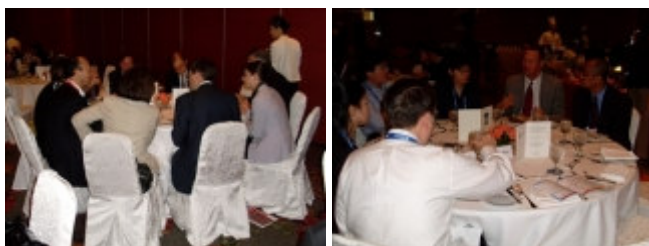

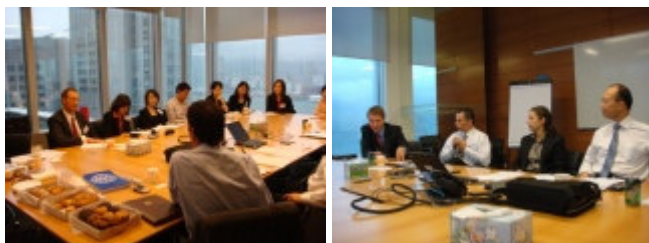
Ministry of Finance/China Tax Bureau Visit in Beijing - April 13-15
